Coverage Explained

Here is a brief explanation of what the plans and their coverage sub-limits entail.

Liability Limits

Liability limits help pay for any civil judgment made against you personally. These are civil lawsuits brought against a federal employee by someone outside the federal government, who is seeking damages for an alleged violation of their constitutional rights.

Administrative Defense Coverage

An administrative proceeding is an investigation (OIG, OSC, OPR, Congressional Oversight Investigation, etc.) brought by the Federal Government against a federal employee. Events that can trigger an investigation include: fire, injury, death, failure of regulatory oversight, potential monetary loss, or breach of national security.

Criminal Defense Coverage

A criminal proceeding is an investigation or proceeding to review or prosecute charges of criminal misconduct for violations of Title 18 of U.S. Code: Crimes and Criminal Procedures. Criminal proceedings can result from facts discovered during administrative proceedings.

Employment Practices Defense Coverage

Our *Career Protector* plan includes an additional sub-limit for employment practices liabilities claims. These include discrimination, wrongful termination, harassment, or retaliation claims that may be filed with the EEOC or within the agency that results in an investigation. This added sub-limit of coverage ensures that the defense of alleged wrong-doings in the employer-employee relationship will not dilute the coverage available for other administrative proceedings.

World Wide Coverage

If you travel overseas and provide foreign services, we recommend our *World Wide* plans. This will provide added protection against claims made by foreign governments. Our Basic plan (and all competitors) will provide coverage for actions performed overseas but the claim made against you must be made in the U.S. or U.S. territories.

Security Clearance Coverage

Coverage to defend against any administrative proceeding to revoke an insured's security clearance included with our World Wide and Career Protector plans

LEOSA & State Conceal and Carry Self-Defense Off Duty Protection Coverage

This coverage is included on our Career Protector Plan to protect qualified active federal law enforcement officers against any liabilities arising out of an act, error, or omission as defined and authorized by the Law Enforcement Officers Safety Act at no additional cost.

Other Products

Over the years the organization has evolved at the request of our constituents to provide the following comprehensive portfolio of products and services any and all of which are also available:

Federal Contractors Insurance:

With the increasing number of Federal employee retirees and the evolution of formal Federal employment to contracting and/or consulting assignments, Starr Wright has received many requests to provide coverage for these less traditional roles. As a result, we have created a simple single source solution to provide Professional Liability, General Liability, BOP, Work Comp, Commercial Auto and the other coverages that may be required or desired.

Life Insurance:

Both a 10 and 20 year group term Life plans are available. These plans are portable and can be maintained even after leaving Federal Government employment. Spousal Coverage is also available with or without the employee electing coverage.

Dental:

Two Dental Health Maintenance Organization (DHMO) options are available through an extensive national network of dentists providing the opportunity to balance need and budget. Benefits are available for employees, spouses, children and families.

Personal Umbrella:

This coverage provides additional liability protection above and beyond traditional personal auto, homeowners and watercraft coverage at affordable rates.

Disability:

Long Term Disability is available with comprehensive benefits.

Benevolent Benefit:

Provides \$10,000 to \$25,000 Life benefit for as little as \$4 a month for members of a group or association which is paid within 48 hours to provide help to cover some of the immediate hardship expenses.
